1. Endowment Charter - NEUMC Everspring Fund

Purpose

The NEUMC Everspring Fund is a permanently established endowment of Northeast United Methodist Church (NEUMC). Its goal is to provide sustainable financial support for the church's ongoing mission and ministries by preserving its principal and distributing dividend and interest income directly to the church's general fund. The Fund is named 'Everspring' to symbolize a perpetual source of support, like a spring that flows continuously, sustaining the church's mission across generations.

Structure

The Fund is overseen by a three-member Everspring Committee, appointed by the Church Council. Members serve staggered six-year terms, ensuring that one seat rotates every two years. To establish this rotation, the initial three members will serve terms of two, four, and six years, respectively.

To preserve independence:

- Committee members may not concurrently hold other leadership positions in the church (such as finance chair, treasurer, or trustee).
- Committee members may not be related by family or have any other close financial or professional nexus to one another.

All members hold equal authority, and the committee functions without a designated chair. Meetings shall be held at least quarterly.

Governance

The Everspring Committee retains exclusive authority over all investment and disbursement decisions related to the Fund. The Trustees of NEUMC will maintain legal custody of the investment account but have no authority to direct or manage fund assets without the unanimous, written consent of the committee.

The church treasurer shall act as the authorized financial agent to execute fund transfers or distributions only upon written direction from the Everspring Committee.

Written account summaries and statements from the investment custodian shall be addressed and mailed to the attention of the Financial Secretary of NEUMC.

All decisions of the Everspring Committee shall require the unanimous agreement of all three members. In the event of an impasse, all committee members agree to submit to internal arbitration facilitated by a disinterested church official, such as the pastor or the Church Council chair, who will mediate and help resolve the disagreement without casting a deciding vote.

Reporting

The committee will submit an annual written report to the Charge Conference that includes both

financial performance and compliance with the Fund's investment policy to the Charge Conference, detailing investment performance, allocation strategy, and disbursements.

Amendments

The terms and policies governing the Fund may only be amended by a unanimous vote of the three committee members.

Vacancies

In the event of a vacancy caused by death, relocation, or resignation, the Church Council will appoint a new member to serve the remaining term within 30 days.

Dissolution

The NEUMC Everspring Fund and its managing committee may be dissolved by a majority vote of a duly convened Charge Conference. Upon dissolution, all assets held in the Fund shall be transferred to the general fund of Northeast United Methodist Church for unrestricted use.

2. Investment Policy - NEUMC Everspring Fund

Philosophy

The investment strategy of the NEUMC Everspring Fund is guided by the United Methodist Church's Social Principles. The committee will maintain a prudent balance between capital growth, income generation, and preservation of principal while ensuring investments reflect the church's ethical values.

Investment Guidelines

- All investments must be considerate of Environmental, Social, and Governance (ESG)
 criteria, which exclude companies whose practices conflict with the United Methodist
 Church's social principles (e.g., tobacco, firearms, or unethical labor practices).
- No more than 20 percent of the Fund's total portfolio may be held in bonds, money market instruments, or certificates of deposit (CDs), collectively considered cash equivalents. This policy reflects the Fund's design as a perpetual endowment with a long-term investment horizon.
- Temporary breaches of this asset allocation threshold are allowable for up to two consecutive months, but not for three or more.
- The Fund shall be managed internally by the Everspring Committee, unless external licensed advisors are engaged. Portfolio rebalancing shall be conducted at the discretion of the Everspring Committee, based on prudent investment principles and the Fund's long-term objectives.
- If external management is used, the total advisory fee must not exceed 1 percent of the Fund's assets under management.

Prohibited Holdings

- The Fund may not hold illiquid or non-publicly traded assets.
- Donations of real estate, tangible property, or non-tradable assets shall not be accepted.

This policy is adopted by the founding members of the Everspring Committee and shall guide the actions of future committee members.

3. Spending Policy - NEUMC Everspring Fund

Accumulation Phase

During the initial growth period, all dividend and interest income will be reinvested until the Fund's balance reaches \$200,000.

Distribution Phase

Once the Fund's balance exceeds \$200,000:

Accumulation Phase

During the initial growth period, all dividend and interest income will be reinvested until the Fund's balance reaches \$200,000 for two consecutive quarters. If the fund falls below \$200,000 for two consecutive quarters, the accumulation phase shall begin anew.

Distribution Phase

Once the Fund's balance exceeds \$200,000:

- Dividend and interest income must be paid out to the NEUMC general fund within one calendar quarter of being received.
- The Committee shall, by default, disburse all dividend and interest income each year. In addition, it may, by unanimous agreement, authorize total annual distributions up to, but not exceeding, 4% of the Fund's balance as of the last trading day of the previous calendar year. This 4% cap includes both dividend and interest income already disbursed. Any decision to distribute more than just dividend and interest income must align with the Fund's long-term objectives.
- All distributions will be transferred to the NEUMC general fund, with the specific use of funds to be determined by the Church Council.

4. Trustee Resolution - Establishment of the NEUMC Everspring Fund

Whereas, Northeast United Methodist Church seeks to promote the long-term financial sustainability of its mission;

Whereas, the Charge Conference has approved the formation of a permanent endowment under ¶2534 of the Book of Discipline;

Be it resolved, that:

- The NEUMC Everspring Fund is hereby formally established as a permanent endowment, intended to preserve its long-term value while distributing income, interest, dividends, and a portion of total return, not to exceed 5% annually, to support the church's general fund.
- A three-member Everspring Committee, appointed by the Church Council, will hold sole authority over all investment and distribution decisions related to the Fund. All disbursements must be made solely to the Northeast United Methodist Church (NEUMC).
- 3. The Board of Trustees shall open and maintain the Fund's investment account in the church's name solely as custodians.
- 4. Trustees shall not access, reallocate, or disburse any portion of the Fund without the unanimous written consent of the Everspring Committee.
- 5. The Everspring Committee shall operate in accordance with the attached Charter, Investment Policy, and Spending Policy.
